## INTERCOLLEGIATE ORATORICAL CONTEST - 2010

**Purpose.** The Woman's Christian Temperance Union believes that young people should be aware of the problems involved with the use of alcoholic beverages, tobacco, illegal drugs and the abuse of prescription and over-the-counter drugs. To encourage and promote research into the effects of these substances as they relate to the health and happiness of the individual, the protection of the home, safety, crime and violence, college students are invited to compete in **State and National Intercollegiate Oratorical Contests** sponsored by the Woman's Christian Temperance Union.

**Contest Outline.** Preliminary contests will be held at the state level. The location and dates of state contests will be announced after consultation with participating educational institutions. Generally, state contest will start about March 15<sup>th</sup>. Each participating state organization is free to set the time and duration of the contest as long as all entries are completed and submitted no later than June 30<sup>th</sup>. Awards shall be given to first, second and third place contestants. Honorable Mention awards may be given at the judges' discretion.

**Sponsorship.** The official sponsor of the contest is the Woman's Christian Temperance Union (WCTU). All rules and regulations are at the sole discretion of the WCTU which supplies the judges and determines the awards. The decision of the WCTU judges is final.

### Contest Deadlines:

**State Contest – June 30<sup>th</sup>.** Winning entries from each county or district contest must be submitted to reach the State Education Director by this date. State Contest rules and judging criteria must comply with the National WCTU Contest rules and judging guidelines.

**National Contest – August** The winning state contest competitor, or runner up if the winner is unable to attend, will compete in the National Contest which is held in conjunction with the annual Convention of the National Woman's Christian Temperance Union. (The Convention location varies from year-to-year)

### Judging Criteria

#### **Subject Matter**

**30%**

1. The general topic must be on the use of beverage alcohol, tobacco, illegal drugs such as cocaine, heroin or marijuana, or the abuse of prescription or over-the-counter drugs, and their related problems; the effects of these substances or their abuse as it relates to the health and happiness of the individual, the protection of the home, safety, crime and violence and economic impact.

2. The content must be original and demonstrate depth of research. A list of at least ten references, five of which must be cited in the oration, must accompany the written version. Personal references should be extremely limited and used sparingly.

3. Abstinence must be referred to as the solution or a significant part of the solution. With respect to medical references and citations, contestants should note that the position of the WCTU is that alcoholism is not a disease but rather a condition that develops from the use of alcohol.

#### **Composition**

**20%**

1. Effective use of language with emphasis on clarity, logical development, structure and word choice will be judged.

2. All orations must state the problem, propose a solution and demonstrate the efficacy of that solution with respect to reduction or elimination of the problem.

#### **Delivery**

**50%**

1. The length of the oration should be eight (8) to ten (10) minutes; no contestant shall be allowed to speak for more than twelve (12) minutes. The speech must be given from memory. **NOTE:** No props, charts or notes will be permitted.

2. Other judging criteria shall include: overall appearance, posture, vocal quality (volume, tone, inflection, emphasis, etc.), pronunciation, effective use of gestures, eye contact, enthusiasm and audience response.

**Additional Requirements for National Competitors:**

Each state winner (or runner-up) who will be participating in the National Contest must send to the WCTU National President the following materials, which must be received on or before July 15<sup>th</sup>.

1. Five (5) typewritten copies of their oration, including title, citations and references. Copies shall be double-spaced on plain, white 8½ X 11 paper.
2. Each submission shall have a cover sheet with the oration title, contestant's name, address, telephone number and e-mail, and shall include a short biographical sketch, and be accompanied by a photograph (head-shot) of the contestant.

**IMPORTANT NOTE:** Submissions not conforming to these rules are subject to disqualification.

**Judges:** There shall be three (3) judges at each level appointed by the contest chairperson. Whenever possible, one or more judges should be a member of WCTU.

**National Awards:**

1 <sup>st</sup> Place	\$500
2 <sup>nd</sup> Place	\$400
3 <sup>rd</sup> Place	\$300

In addition to these awards, each participant not receiving a place award in the National Contest will receive a \$50 participation award.
